

## **GENERAL REGULATIONS**

### **Regular donations for Hot Meal Programme of BRC**

#### **1. DEFINITION**

**Under the present General Regulations:**

**1.1. A DONOR** is each person who donates through SMS via mobile phone to the short number 1255 for supporting Hot Meal Programme of BRC.

**1.2. Endowed is the BULGARIAN RED CROSS**, Reg. № 24766/92, address: 1407 Sofia, 76 James Bourchier Blvd., represented by the President Hristo Grigorov.

**1.3. Hot Meal Programme** is a Programme for supporting needy Bulgarian children with a free lunch at school during the school year.

**1.4. Methods of donation** are the individual one-time or regular donations through SMS according to the present General Regulations.

#### **2. RIGHTS AND OBLIGATIONS OF THE PARTIES.**

**2.1. The DONOR** agrees to support the Hot Meal Programme of BRC either through one-time or regular SMS donations.

**2.2. The BRC** from its part thankfully accepts the donor's will to support its work in accordance with the Hot Meal regulations.

**2.3. The Beneficent** is obliged to use the donated funds only to support the needy children to receive free lunches at school during the school year through the Hot Meal Programme of BRC.

#### **3. METHODS OF DONATION.**

##### **3.1. One-time donations through SMS.**

Through SMS to the short number 1255 for the clients of all mobile operators, the DONOR donates 1 BGN for providing a needy child with a free hot meal at school. After the donation has been received, the DONOR receives back a thanksgiving SMS, proposing him/her to donate each month 2 or 5 BGN.

##### **3.2. Regular donations through SMS.**

Through sending a new SMS to the short number 1255 with a number „2” or „5” for the clients of all mobile operators, the DONOR accepts to donate each month 2 or 5 BGN respectively to support the Hot Meal Programme of BRC. There is no VAT to this sum.

After that, the DONOR receives a thanksgiving SMS, informing him/her about the chosen donation, as well as how to change or cancel it.

#### **4. USE OF THE RAISED FUNDS.**

The BENEFICENT guarantees that the raised funds through one-time or regular SMS, will be used only for supporting needy children all over the country with free lunches at school.

#### **5. COMMUNICATIONS.**

**5.1.** Through the monthly SMS the DONOR will be directed to the BRC website [www.redcross.bg/](http://www.redcross.bg/), where he\she could find detailed information about the use of the raised funds, the number of the children, included in the Programme and the results of the campaign.

**5.2.** Each DONOR, who sends either one-time or regular SMS to support the Hot Meal Programme of BRC, agrees to receive back informational SMS in relation with the humanitarian causes of the organization.

#### **6. ENTRY INTO FORCE, VALIDITY AND TERMINATION.**

**6.1.** The DONOR agrees to support the Hot Meal Programme of BRC with monthly donations for 12 consecutive months.

**6.2.** The DONOR can cancel the donations any time by sending SMS.

**6.3.** The DONOR can change the donations from 2 to 5 BGN and the other way from 5 to 2 BGN through SMS with the new number. This message is free. The change is valid since the following period of payment.

**6.4.** In case the DONOR stops his/her monthly donations, the DONOR will not be reimbursed for the previously made donations.

#### **7. ADDITIONAL CLAUSES.**

**7.1.** By joining to support the BRC Hot Meal Programme, the DONOR agrees with the present General Regulations according to their last version, published on the BRC website: [www.redcross.bg](http://www.redcross.bg).

**7.2.** Any changes of the present General Regulations, made by the BRC will be updated and published on the website of the organization.

**7.3.** The BENEFICENT will keep to all the regulation and rules regarding the Hot Meal Programme.

**7.4.** Any other additional issues are applied to the Current Legislation.

**7.5.** The present General regulations are published on the BRC website on 01.03.2016.
